The City University of Hong Kong (CityU) aspires to become a leading global university, excelling in research and professional education. In 2014, it has been ranked 108th in the QS World University Rankings and 5th in QS world's top 50 universities under 50 years of age. The College of Business stands at 46th in the world and 2nd in Asia-Pacific region (The UTD Top 100 Business School Research Rankings, the University of Texas at Dallas 2009-2013).

The Department of Economics and Finance provides solid training in both the theory and application of economics and finance. It aims at training graduates with cutting-edge knowledge in modern economics and finance and providing Hong Kong with young financial executives, economists, and business analysts it needs. The mission of the Department is to be a center of excellence in research and teaching, using economics and finance for business as well as public sector decision-making in Hong Kong, mainland China, and other Asia-Pacific economies.

The Department has over 850 undergraduate students and 250 postgraduate students with diverse backgrounds. Most of our postgraduate students are graduates of prestigious universities in Hong Kong and mainland China, as well as overseas countries including USA, Canada, UK, Germany, etc.

Several faculty members have been honored as exemplary teachers. In addition, many faculty members have outstanding research publication records, with their publications appearing regularly in internationally reputed refereed journals. Research interests include International Trade, Corporate Finance, and Corporate Governance, etc. Based on research publications, the Department is ranked by published studies in the top tier among all universities in the Asia-Pacific region, including Australia and New Zealand.

General Information

The MSAE programme provides students with a rigorous training in economic analysis, empirical and quantitative methods. The programme is designed to enhance students' ability in analyzing economic

policies, making business decisions, and performing applied economics research. Students will be exposed to the applications of modern economic theories in solving real world problems. Graduates of MSAE programme are well qualified to pursue further studies at the PhD level or work as professional economists in business and governmental organizations.

Programme Features

Admission Requirements

Applicants must hold a bachelor's degree from a recognized university. An undergraduate degree in economics or related areas is not a pre-requisite. Students with a solid quantitative background and commitment to academic study are encouraged to apply.

Applicants whose bachelor's degree is obtained from an institution where the medium of instruction is not English should also fulfill the following minimum English proficiency requirement:



- A TOEFL score of 550 (paper-based test) or 213 (computer-based test) or 79 (internet-based test); or
- An overall band score of 6.5 in International English Language Testing System (IELTS); or
- A score of 490 in the new College English Test (CET-6) of Chinese mainland or a pass in the old CET-6 Test; or
- Other equivalent qualifications
