- Exchange students are welcome to join courses from the following Bachelor programs offered by the School of Economics and Management (TiSEM):
 - BSc in International Business Administration
 - BSc in Economics and Business Economics
 - BSc in Economics
 - BSc in Econometrics and Operations Research
 - BSc in Economics and Informatics
- Moreover, TiSEM offers the following co-curricular programs to exchange students:
 - Semester 1: International Entrepreneurship Program
 - Semester 2: CentER Honors Program

The International Entrepreneurship Exchange Program offers exchange students the opportunity to hone their entrepreneurial skills, to put theory into practice and to fulfill their business dreams. This program also gives valuable insight into the importance of an entrepreneurial mindset, therefore, students who have not taken their first steps yet and who would like to know more about this valuable skill are welcome to participate too. A limited number of places is available to participate in this program.

TiSEM offers the CentER Honors Program to outstanding exchange students (Spring semester only; availability for 2013 is still subject to change). Participants have an extra workload of 7-10 ECTS on top of the regular workload of 12-18 ECTS. A limited number of places is available to the most ambitious and excellent students. - Semester 1 = Fall semester 2012; Semester 2 = Spring semester 2013
- Entry requirements or a restricted number of participants may apply to certain Bachelor courses. Always check before submitting your course proposal if you meet the academic prerequisites or other requirements (to be found in the online study guide or on the Center Honors Program website). Students are admitted to courses after a positive assessment of their academic background.
- Courses from the Master programs offered at TiSEM are only available to Master level students.
- We recommend choosing courses from one Bachelor program and within one year of that program (if possible) to avoid class overlapping as much as possible. In any case, please carefully check the schedules, since classes should not overlap. For the ease of choosing courses, you can find them ordered by Bachelor program on pages 3 and 4. Some programs give students the possibility to choose free electives and it will be taken into account with scheduling classes, the free electives can be found at the bottom of page 4.
- The fulltime/maximum workload is 30 ECTS credits per semester; the minimum required load is 24 ECTS. We
 need a written approval from your home university if you want to take less than 24 ECTS. Students
 participating in the CentER Honors Program have an extra workload of 7 up to 10 ECTS on top of the regular
 24-30 ECTS.



- Course enrolment will be based on your TiSEM exchange application form. Choose conscientiously. Making changes to your choice after arrival in Tilburg is only possible in exceptional cases.
