# Information About the Talk on "Some Recent Economic issues related to China"

China has been experienced an admirable economy growth since its adoption of the open door policy and the subsequent economic reform programs less than 30 years ago. The impacts of the Chinese economy on the global economy are usually discussed with the usual hyperbole. The discussion of economic issues related to China, however, are more often based on some imprecise, if not illusive, arguments rather than on sound and rigorous economic reasoning. In the talk, we offer a balanced-approach to decipher some hotly debated economic and policy issues related to China.
